## TWO INDIANA CPE SUPERVISORS DISCOVER AMAZING COINCIDENCE IN OHIO

John Peterson of Lutheran Hospital of Fort Wayne and Chuck Doughty of Deaconess Hospital in Evansville served on an accreditation site team in Ohio, December 8-9. As the visit neared completion, Peterson said to the other team members, that he was looking forward to going to work the next day, since it would be his 20th anniversary at the hospital. Doughty looked a little awestruck and remarked, "Hey! That's my 20th anniversary at Deaconess!" What are the odds that two people of three picked for a site team would have begun their service on the same day in the mid 80's, at centers that they continue to serve?

Chuck began work in 1984 with Joe Foster who started the CPE program at Deaconess in 1969. Even though he has been at Deaconess for twenty years, Chuck is still the relative newcomer. Chaplain Foster, who just recently retired, had been at Deaconess for thirty-five years and Fr. Robert Wannemuehler who is now a volunteer chaplain has served for over thirty-five years. After several years as a CPE supervisor and CPE Coordinator, Chuck became the manager of the Religious Life Department upon the retirement of Joe Foster, and Chaplain Elizabeth Price joined the staff in January 2004 as the new Coordinator.

John began at Lutheran in 1984 as the hospital decided to initiate a CPE program, primarily to serve Concordia Seminary in Fort Wayne. 1985 was spent getting candidacy accreditation, and the first students were accepted in January 1986. The program has functioned continuously since that time. At Lutheran, John has been blessed to work with some of the finest supervisors anywhere, including Cal Brand, Kathy Nininger, Bob Leas, and (currently) Joe Viti. Major changes during the time include moving to a new campus in 1991, and Lutheran's becoming an investor owned hospital in 1995. It seems that every time John has gotten restless and sought a change in his professional life, the hospital has undergone a change radical enough to make it seem like a new job.
